Introduction

The following interim management's discussion and analysis ("MD&A") of Rupert Resources Ltd. ("Rupert" or the "Company") for the three months has been prepared to provide material updates to the business operations, liquidity and capital resources of the Company since its last annual management's discussion & analysis ("Annual MD&A") for the fiscal year ended February 28, 2018. This MD&A does not provide a general update to the Annual MD&A, or reflect any non-material events since date of the Annual MD&A.

This MD&A was written to comply with the requirements of National Instrument 51-102 - Continuous Disclosure Obligations. This discussion should be read in conjunction with the unaudited condensed interim financial statements for the three months ended May 31, 2018 in addition to the audited annual financial statements for the years ended February 28, 2018 and February 28, 2017, together with the notes thereto. Results are reported in Canadian dollars, unless otherwise noted. The Company's financial statements and the financial information contained in this MD&A are prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB") and interpretations of the IFRS Interpretations Committee ("IFRIC"). The unaudited condensed interim financial statements have been prepared in accordance with International Accounting Standard 34, Interim Financial Reporting. Accordingly, they do not include all of the information required for full annual financial statements required by IFRS. Information contained herein is presented as of July 27, 2018, unless otherwise indicated.

For the purposes of preparing this MD&A, management, in conjunction with the Board of Directors, considers the materiality of information. Information is considered material if: (i) such information results in, or would reasonably be expected to result in, a significant change in the market price or value of Rupert's common shares; (ii) there is a substantial likelihood that a reasonable investor would consider it important in making an investment decision; or (iii) it would significantly alter the total mix of information available to investors. Management, in conjunction with the Board of Directors, evaluates materiality with reference to all relevant circumstances, including potential market sensitivity.

Description of Business

Rupert is a company incorporated under the laws of the Province of British Columbia. The Company is currently seeking out viable mineral exploration and evaluation opportunities and has five projects located in Ontario, British Columbia and Finland.

The ability of the Company to continue as a going concern is dependent upon its ability to obtain additional financing. Rupert's financial statements have been prepared on the basis that the Company is a going concern and do not include adjustments that would be necessary should the Company be unable to continue as a going concern. The Company is actively seeking additional sources of liquidity and reducing discretionary expenditures where possible in order to preserve and enhance its liquidity.

The Company's outstanding common shares trade on the TSX Venture Exchange under the symbol RUP. As at May 31, 2018, an investor of the Company, Alan Brimacombe, controls 20,076,300 common shares of the Company or approximately 17.98% of the total common shares outstanding. To the knowledge of directors and officers of Rupert, the remainder of the Company's outstanding common shares are widely held. These holdings can change at any time at the discretion of the owner.

Overall Performance

The following significant events occurred during the three months ended May 31, 2018:

The Company announced on March 2, 2018 that it had closed a financial placement (the “**March 2018 financial placement**”) and had issued 5,903,615 common shares in the Company at a price of \$0.83 per common share for gross proceeds of \$4,900,000.

On March 20, 2018 the Company entered into a binding, definitive share exchange agreement with Northern Aspect Resources Limited (“**NARL**”) and all of the shareholders of NARL to acquire all of the issued and outstanding securities in NARL (the “**NARL transaction**”), subject to certain conditions, including *inter alia*, definitive approval from the TSX-V.

On April 16, 2018 the Company announced a Mineral Resource Estimate for the Pahtavaara project (“**Pahtavaara**”) in the Central Lapland Greenstone Belt in Northern Finland (“**CLGB**”) and prepared in accordance with NI 43-101 and comprising 4.64 million tonnes (“**Mt**”) in the Inferred category, grading 3.2 grammes per tonne (“**g/t**”) gold (“**Au**”) for 474 thousand ounces (“**koz**”) Au at a cut off of 1.5 g/t Au.

On May 15, 2018, the Company announced that it had received from the TSX-V, definitive approval to acquire all the issued and outstanding securities of NARL and that it had completed the NARL transaction through issue of 4,913,466 consideration shares at a deemed value of \$0.85 per share.

On May 30, 2018 a technical report to support the Mineral Resource Estimate for Pahtavaara was filed and titled “NI 43-101 Technical Report: Pahtavaara Project, Finland” (the “**Pahtavaara Report**”).

At May 31, 2018, the Company had a working capital of \$5,380,608 (February 28, 2018 – \$4,556,163). The \$824,445 increase in working capital during the three months ended May 31, 2018 was primarily due to the \$689,329 increase in cash, offset by a decrease in prepaids and sundry receivables as a result of operating activities and expenditures on exploration and evaluation assets and buildings and equipment. The Company had cash of \$6,176,736 at May 31, 2018 (February 28, 2018 - \$5,487,407). The increase in cash during the three months ended May 31, 2018 was primarily due to the cash raised from the March 2018 financial placement, offset by operating and investing activities.

Additional financing will be required to fund operating expenses as it searches for suitable assets or businesses to merge with or acquire. See "Liquidity and Capital Resources".

Change of Management

On June 25, 2018 Mr. Gunnar Nilsson assumed the role of non-Executive Chairman of the Company, replacing Mr. Brian Hinchcliffe, who was the Executive Chairman until that date. Mr. Nilsson was previously a Director of NARL. Prior to this Mr. Nilsson held senior roles at Johnson & Johnson and Svenska Cellulosa/Mölnlycke before retiring to act as a private investor. Mr. Nilsson has over 30 years experience of developing and operating businesses in Europe and through joint venture companies outside Europe.

Potential Dilution

The issue of common shares of the Company upon the exercise of the options and warrants will dilute the ownership interest of the Company's current shareholders. The Company may also issue additional options and warrants or additional common shares from time to time in the future. If it does so, the ownership interest of the Company's then current shareholders could also be diluted.

Exploration and Evaluation Update

Discussion of Operations

Pahtavaara, Northern Finland

Geology and Exploration

The geology program at Pahtavaara is comprised of two main work streams. Firstly, the drill definition of new resources in close proximity to underground mine infrastructure and at surface within 1km of the Pahtavaara mill. Secondly, evaluation of the resource potential on the wider claims held by Rupert at Pahtavaara.

Since June 2016 the Company has completed 53,669 metres of diamond drilling in 388 holes at Pahtavaara. Drilling was paused July 2017 to consolidate all existing drill data and focus resources on developing a new geological model for Pahtavaara. Following a re-evaluation of previous drilling, geophysics and geological data, combined with the results of the summer 2017 fieldwork, a 6,000 metre surface drilling program recommenced in November 2017. Of this drilling, approximately 50% targeted in-mine infill or extension targets, and the balance on nine ranked exploration targets, all within 4km of the Pahtavaara mill.

During the three months ended May 31, 2018, the Company spent \$896,010 (three months ended May 31, 2017 - \$2,651,254) on general exploration costs.

New NI 43-101 compliant mineral resource estimate for Pahtavaara

On April 16, 2018 the Company announced a Mineral Resource Estimate for Pahtavaara and prepared in accordance with NI 43-101 and comprising 4.64 million tonnes in the Inferred Category, grading 3.2 g/t Au for 474,000 oz Au at a cut off of 1.5 g/t Au. On May 30, 2018 the Pahtavaara Report was filed

Expanded licence package

In the quarter ended May 31, 2018 the Company applied for further reservations expanding Rupert's contiguous licence holding in the CLGB to an area totalling 290.87km². As of the date of this document, two exploration licence applications were pending. None of the Company's claims are located on the Natura 2000 areas.

Central Finland properties

On May 15, 2018, the Company announced that it had completed the NARL transaction. NARL, through its wholly-owned subsidiaries holds the Hirsikangas and Osikonmaki properties in central Finland. The Hirsikangas deposit in Central Finland is a Paleoproterozoic orogenic gold deposit located on a 30km crustal scale shear zone. Using a 0.5 g/t Au cut off grade, Hirsikangas has a mineral resource in the Indicated category of 3.002 Mt at a grade of 1.23 g/t Au for 119 koz Au and a mineral resource in the Inferred category of 2.673 Mt at a grade of 1.27 g/t Au for 106 koz Au (collectively, the "Hirsikangas

Resources"). The Hirsikangas resources are contained within 1.2km of strike length and drilled at shallow levels. The prospect, that outcrops at surface, is open down dip and along strike in both directions and there is evidence of a potential parallel structure. The Hirsikangas Resources were defined in a technical report prepared in accordance with NI 43-101 and titled "Hirsikangas Gold Deposit, Central Ostrobothnia, Finland", dated November 30, 2009 (the "**Hirsikangas Report**")

The deposit at Osikonmaki is located in eastern central Finland, 40km south of Outokumpu. The model for Osikonmaki is an epigenetic intrusion related shear zone gold deposit. Gold is concentrated in the footwall to the shear zone, In excess of 20km of historic drilling, IP and magnetic geophysical surveys and base of till geochemical sampling has been undertaken at the project with potential for extensions outlined. Using a 0.5 g/t Au cut off grade, Osikonmaki has a mineral resource estimate in the Indicated category of 1.296 Mt at a grade of 1.70 g/t Au for 68 koz Au and a mineral resource in the Inferred category of 3.542 Mt at a grade of 2.09 g/t Au for 244 koz Au (collectively, the "**Osikonmaki Resources**"). The Osikonmaki Resources are defined in a technical report prepared in accordance with NI 43_101 titled "Mineral Resource Estimate of the Rantasalmi Gold Deposit in Finland" and dated October 10, 2011 (the "**Osikonmaki Report**").

Gold Centre Property, Ontario and Surf Inlet Property, British Columbia

A review of previous work and land position of the Gold Centre and Surf Inlet properties has been completed. During the nine months ended May 31, 2018, the Company spent \$nil (three months ended May 31, 2017 - \$nil) on general exploration costs.

Discussion of Operations

Three months ended May 31, 2018, compared with three months ended May 31, 2017

Rupert's net loss totaled \$1,261,400 for the three months ended May 31, 2018, with basic and diluted loss per share of \$0.01. This compares with a net loss of \$1,380,578 with basic and diluted loss per share of \$0.01 for the three months ended May 31, 2017. No revenue was recorded in either period.

The net loss decreased by \$119,178 due to the following:

Share-based payments decreased by \$164,932 as a result of the stock options vested.

General and administrative expenses increased to \$544,068, which was \$12,029 higher than the comparable period primarily due to increases in salaries and benefits of \$62,176, office and sundry of \$5,100, and transfer agent costs of \$2,461. The increase was offset by decreases in travel of \$47,400, professional fees of \$5,679 and consulting fees of \$4,818

Accretion & interest expense of \$301,907 (non-cash) was incurred as a result of the convertible debentures, as compared to \$267,724 for the three months ended May 31, 2017.

Liquidity and Capital Resources

As at May 31, 2018, the Company had working capital of \$5,380,608 (February 28, 2018 -\$4,556,163). The Company is seeking additional sources of liquidity (see "Overall Performance"). There can be no assurance that additional financing or shareholder loans, if and when required, will be available on terms acceptable to the Company.

As at the date of this MD&A, the Company had 111,679,573 issued and outstanding common shares, 8,315,000 stock options with exercise prices between \$0.08 and \$1.01, and expiry dates between January 2019 and April 2022.

Risks and Uncertainties

The Company's business of exploring for mineral resources involves a variety of operational, financial and regulatory risks that are typical in the natural resource industry. The Company attempts to mitigate these risks and minimize their effect on its financial performance, but there is no guarantee that the Company will be profitable in the future, and the Company's common shares should be considered speculative in nature.

The business of exploration for minerals and mining involves a high degree of risk. A relatively small proportion of properties that are explored are ultimately developed into producing mines. At present, there are no known bodies of commercial ore on any of the mineral properties in which the Company holds interest or intends to acquire an interest and the proposed exploration program is an exploratory search for ore. Unusual or unexpected formations, formation pressures, fires, power outages, labour disruptions, flooding, cave-ins, landslides and the inability to obtain suitable or adequate machinery, equipment or labour are other risks involved in the conduct of exploration programs. The Company has limited experience in the development and operation of mines and has relied on and may continue to rely upon consultants and others for exploration and operating expertise. The economics of developing gold and other mineral properties is affected by many factors including the cost of operations, variation of the grade of ore mined, and fluctuations in the price of any minerals produced.

The success of the Company is dependent, among other things, on obtaining sufficient funding to enable the Company to explore and develop its properties. There can be no assurance that the Company will be able to obtain adequate financing in the future or that the terms of such financing will be favourable. Failure to obtain such additional financing could result in delay or indefinite postponement of further exploration and development of its projects with the possible loss of such properties. The Company will require new capital to continue to operate its business and to continue with exploration on its mineral properties, and there is no assurance that capital will be available when needed, if at all. It is likely such additional capital will be raised through the issuance of additional equity, which will result in dilution to the Company's shareholders.

The operations of the Company may require licenses and permits from various local, provincial and federal governmental authorities. There can be no assurance that the Company will be able to obtain all necessary licenses and permits that may be required to carry out exploration, development, or mining operations, at its projects.

Even if the Company's exploration programs are successful, factors beyond the control of the Company may affect the marketability of any mineral products discovered. The prices of mineral products have historically fluctuated widely and are affected by numerous factors beyond the Company's control, including international, economic and political trends, expectations for inflation, currency exchange fluctuations, interest rates, global or regional consumption patterns, speculative activities and worldwide production levels. The effect of these factors cannot accurately be predicted.

The mining industry is intensely competitive. The Company competes with many companies possessing greater financial resources and technical facilities than itself for the acquisition of mineral interests as well as for the recruitment and retention of qualified employees, contractors and consultants.

The Company's operations are subject to environmental regulations promulgated by local, provincial and federal government agencies from time to time. Environmental legislation provides for restrictions and

prohibitions of spills, releases or emissions of various substances produced in association with certain mining industry operations, such as seepage from tailing disposal areas, which could result in environmental pollution. A breach of such legislation may result in the imposition of fines and penalties. In addition, certain types of operations require submissions to and approval of environmental impact assessments. Environmental legislation is evolving in a manner, which means stricter standards and enforcement, and fines and penalties for non-compliance are more stringent. Environmental assessments of proposed projects carry a heightened degree of responsibility for companies and directors, officers and employees. The cost of compliance with changes in governmental regulations has a potential to reduce the profitability of operations. The Company intends to fully comply with all environmental regulations.

Certain directors or proposed directors of the Company are also directors, officers or shareholders of other companies that are similarly engaged in the business of acquiring, developing and exploiting natural resource properties. Such associations may give rise to conflicts of interest from time to time. The directors of the Company are required by law to act honestly and in good faith with a view to the best interests of the Company and to disclose any interest, which they may have in any project opportunity of the Company. If a conflict of interest arises at a meeting of the Board of Directors, any director in a conflict will disclose his interest and abstain from voting on such matter. In determining whether or not the Company will participate in any project or opportunity, the directors will primarily consider the degree of risk to which the Company may be exposed and its financial position at that time.

The Company does not have a historical track record of operating upon which investors may rely. Consequently, investors will have to rely on the expertise of the Company's management. Further, the Company's properties are in the exploration stage and are not commercially viable at this time. The Company does not have a history of earnings or the provision of return on investment, and there is no assurance that it will produce revenue, operate profitably or provide a return on investment in the future.

At present, there are no known bodies of commercial ore on any of the mineral properties in which the Company holds interest or intends to acquire an interest and the proposed exploration program is an exploratory search for ore. Further, the Company's properties are in the exploration stage and are not commercially viable at this time.

Management's Responsibility for Financial Information

The Company's financial statements are the responsibility of the Company's management, and have been approved by the Board of Directors. The financial statements were prepared by the Company's management in accordance with Canadian generally accepted accounting principles. The financial statements include certain amounts based on the use of estimates and assumptions. Management has established these amounts in a reasonable manner, in order to ensure that the financial statements are presented fairly in all material respects.
